### Information

The S.S.A.A. Oakdale Pistol Club range is located off the Flagstaff Gully Link Road in Warrane. The range is primarily for handguns but has been approved for limited longarm events. No centrefire rifles are allowed except for lever actions in calibres approved for Cowboy Lever Action Silhouette & Single Action Shooting events. **No bolt action centrefire rifles are allowed !!**

*Handgun events are;*

1. **Handgun Metallic Silhouette (I.H.M.S.A.)**
  - i) *Rimfire Silhouette*
  - ii) *Centrefire Silhouette*
  - iii) *Field Pistol Silhouette*
2. **IPSC Style Practical Pistol**
3. **Service Pistol & ISSF Slowfire**
4. **NRA Style Action Pistol**

*Longarm events are;*

1. **Cowboy Lever Action Silhouette**
  - i) *Rimfire Lever Action Silhouette*
  - ii) *Pistol Calibre Lever Action Silhouette (100 metres)*
  - iii) *Centrefire Lever Action Silhouette (200 metres)*
2. **Rimfire Metallic Silhouette Rifle**
3. **IPSC Style Practical Rimfire Rifle & Practical Shotgun**
4. **Single Action Shooting – Cowboy Action Match**

To be eligible to join the S.S.A.A. Oakdale Pistol Club you must be a member of the **Sporting Shooters Association of Australia**. If you are not already a member an application form is included with the Oakdale application. Your nominated home branch should be **T01 Oakdale**, or you will only qualify to become an associate member.

#### How To Join The Club

1. Complete the SSAA Oakdale Application for Membership and submit it to the committee for acceptance. Submission options are on the application form. Include a non-refundable deposit of **\$10.00**. This will be deducted from the \$25.00 joining fee.
2. If you are not already a member of the *Sporting Shooters Association of Australia*, you must join now. This is mandatory to obtain Oakdale membership. Application is included.
3. Upon committee acceptance, your minimum 3-month probation will begin. During this time, you must attend at least **5** introduction/information sessions and have your probation attendance form signed. ***This needs to be completed within 6 months or your probationary status will be forfeit and you will need to begin the process again.***
4. If you don't have a Tasmanian Firearms licence, you can apply for an **Exemption** from the commissioner of police, form attached. If your application is successful, you will be allowed to shoot at Oakdale, unlicensed, for 6 months. After this, you must have a target shooting endorsed firearms licence to continue to shoot.
5. You can also sign up to attend the TAFE firearms safety training course. This is the first step in attaining your Tasmanian firearms licence.
6. After the successful completion of your probation your application and probation attendance will again be tabled at a committee meeting for approval. Once approved you will be sent an account for the balance of your joining and pro rata membership fees. Once these monies are deposited, we will notify you and Firearms Services of your full membership status with S.S.A.A. Oakdale Pistol Club.
7. Each member is required to attend a minimum of 2 working bees each financial year. (*July 31 to June 30*) A levy will be added to your subscription renewal for each non-attendance. (*up to a maximum of \$100*)

## Sporting Shooters' Association of Australia (Tasmania) Oakdale Pistol Club Inc.

New members must complete a probationary period of three months and attend at least **five (5)** introduction/information sessions before the committee will consider full membership. ***This needs to be completed within 6 months or your probationary status will be forfeit and you will need to begin the process again.***

Probationary members are expected to help out wherever possible when they attend the range. *Merely turning up and staying long enough to have your form signed or sitting in the shed doing nothing is regarded as unacceptable and will not count as an attendance.* You should also take every opportunity during these attendances to familiarise yourself with the range commands and safety requirements of target shooting competition. It is during this period that you will have the chance to meet and talk with many experienced target shooters and any queries you might have concerning your new sport or your future firearm purchase can be clarified. Ear and Eye protection is highly recommended whenever attending the range.

A minimum of **two (2)** static matches, i.e. no movement, (*Service or Action*), must be completed by new members before any matches involving movement, (*Practical*), can be attempted. This is for you to learn the range commands and handling techniques associated with the safe and proper use of holsters and semi automatic pistols. ***Safety is our paramount concern on the range.*** The two lines below marked **x** are for this purpose.

*After attending at least five (5) introduction/information sessions you must arrange to complete a **Gun Handling & Safety Check**. This process is vital, and you will not be allowed to shoot at Oakdale if you do not complete it satisfactorily. You will need to complete a **Gun Handling & Safety Check** for each discipline you intend to compete in.*

**Please give the discipline captain prior notice that you would like to complete the *Gun Handling & Safety Check* as it will be conducted after a shoot and they need to make time available.**
